# Course description and objectives:

The objective of this course is to develop an understanding of basic concepts and mechanisms in microeconomics. Among others, we will answer the following questions: How do rms and households make production and consumption decisions? How do market mechanisms work and when do they fail? What is the role of government regulations and taxation? Why do countries trade? We will review these and other questions through the lens of both microeconomic theory and real world data.

### Requirements and prerequisites:

The are no prerequisites for this course. Good understanding of basic algebra will be helpful.

There will be no make up exams or extra-credit assignments. If your scores for <u>both</u> midterms are in top 5% of the class, you will get 10% added to your nal exam.

Extra credit assignments are not required. Only complete them if you need additional practice/help with your reading or you feel that you will need extra points. Extra-credit points can account for a maximum of 2% of your total grade. Extra-credit assignments will have deadlines and are accessible via *Achieve*.
